

PG&E Tree Removals

While our friends at **Save Oroville Trees** have continued their daily round-the-clock vigils on site at the Oroville Cemetery to protect the remaining nine trees.

Save Oroville Trees organizers have been camping out overnight in front of the trees, prepared to activate their phone tree when the work crews return. **Over 100 citizens** showed up on Monday morning at dawn to confront the tree crews, many prepared to be arrested by putting themselves between the trees and the chainsaws. But the crews didn't come that day.



This morning (Thursday) the tree crews arrived. Protesters are being arrested and their vehicles are being towed. By the time you read this, the last 9 remaining trees will likely be down.

More Tree Removals Planned for Chico, Paradise, & the Midway

Meanwhile, BEC has been working hard to learn about PG&E's plans for tree removals along the Midway, around the Comanche Creek area in Chico and up towards Paradise along Neal Road.

After much Nancy Drew-style sleuthing for details and answers, we have managed to gather a few documents provided by the City of Chico, Butte County, and PG&E but still have many unanswered questions about which trees will be cut, when they will be cut, whether there are plans for tree replacements, and who will be responsible for the ongoing maintenance costs with planting new immature trees.

Over 100 of the iconic trees along the Midway were considered for removal, but as reported in the <u>Chico E-R on Jan. 30th</u>, the final list indicates 32 trees along the bike path. Of those, most are smaller diameter trees and are either Chinese Pistache or Pepper trees.

In Chico, we've learned there are 84 trees to be removed. Some removals already took place in the Comanche Creek Greenway area and on Estes Rd. Many of the trees removed were invasive or non-natives including ailanthus (Tree of Heaven), Black Walnut, and Chinese Pistache. There were also 25 "small diameter" Valley Oaks.

PG&E has said they intend to plant replacement trees as mitigation for the loss of the mature trees. But while mature trees require little maintenance, new trees will have at least 3 years of maintenance costs including watering and pruning. Will the City of Chico be asked to foot the bill or will all those costs be

accounted for? When, where, and by whom will the trees be planted?

BEC is working hard to get answers and is calling on PG&E to hold a public meeting before any further trees are removed. County staff have assured us they will hold any permit requests until PG&E provides an opportunity for public review of their plans. We have urged the City of Chico to do the same for the remaining proposed removals. What happened in Oroville must not be repeated in Chico and the County unincorporated areas.

Local Climate Action & Statewide Action in Oakland: Feb 6 & 7

BEC has launched a year of climate action leading up to the Paris Climate Summit in December 2015. Our next action event will be this **Friday night**, **Feb. 6th** at 5 p.m. to kick-off the big "Action on Climate Leadership" march in Oakland the following day.



A charter bus has been organized by Frack-Free Butte County to take local folks down to Oakland on Saturday, Feb. 7th for the statewide March for Real Climate Leadership. Currently the bus is full with a waiting list and ride shares are being organized through GroupCarpool.com. Anyone who wants to give or get a ride can meet up at the Butte College Chico Center parking lot at 7:30 a.m. on Saturday, Feb. 7th.

BEC's hosting the Friday evening send-off party of art and music at the Habitat Lab (199 E 13th St in Chico) the night before to get more local folks involved and to make signs for the march. It will be an infectious evening of activism and art.

Fracking Ban Final Hearing

Will Butte County finally ban fracking next week? It might depend on how many supporters show up on Tuesday, February 10th to show community support for the ban!

A final vote by the Board of Supervisors will take place at a public hearing on the Ordinance to Ban



Hydraulic Fracturing in Butte County on **Tuesday, Feb. 10th.** The meeting begins at 9 a.m. and this agenda item is scheduled to begin at 10:45 a.m. at the Board of Supervisors Chambers, 25 County Center Drive in Oroville.

BEC has actively participated with the Frack-Free Butte County campaign which began organizing in summer 2013 to ban fracking (hydraulic fracturing for natural gas extraction).

We are at the finish line of a year and a half-long race to ban fracking in Butte County and protect precious water, air, and health. To get us across the finish line, we need all hands on deck - **and that means you!**

Ask the Board to honor their April 2014 vote to ban fracking and respect the resolution of the 10,000 signatures collected to ban fracking in our county. The oil and gas industry is exerting tremendous pressure and employing scare tactics on the Board. Show them the public support they need to do the right thing and protect Butte County's water, air, and health.

I'm asking you to do three things that will make or break a victory on Feb. 10th:

- 1. Call your supervisor (information below)
- 2. Write your supervisor (information below)
- 3. Pack the room at the Board of Supervisors meeting Tuesday, February 10th at 9am County Supervisors Chambers, 25 County Center Drive, Room 205, Oroville 95965

The opposition seems mighty, but we have the voice of the people on our side. So let the board hear you loud and clear: "Ban Fracking in Butte County!"

Rainbows belong in the sky not on the Ground!

For most folks these day, oil changes seem to consist of driving ones car to a garage, waiting patiently for the technician to check all fluids in the vehicle and then simply signing your name on the dotted line. However, for the true do-it-yourself individual



it is an exercise that is of utmost importance and skill.

Changing the oil in my car was one of the first things that my Dad made sure I knew how to do before I could take on the responsibility of being a licensed driver. It was important to him that I understood the importance of taking care of my vehicle and the importance of being environmentally conscious while doing so.

When not properly disposed of, **one gallon of oil can contaminate 1 million gallons of fresh water**, enough to supply 50 people with drinking water for a year. Every year, 20 times more oil is dumped carelessly into water sources than was released during the Valdez oil spill.

Here are few tips that you can keep in mind if you are passing these same predriving tests onto your children, friends and neighbors.

- Do not spill any oil on the ground.
- Put your used motor oil in a clean plastic container with a tight lid. Never store used oil in a container that once held chemicals, food or beverages.
- Do not mix the oil with anything else, such as antifreeze, solvent or paint.

Bioswales: New Focus For Watershed Program

2014 was a big year for water politics and management; for the first time in California's history, **groundwater will be regulated** and the state is asking regions to live within their local water budgets. What these new laws are asking of us is that we look deeper and find longer term solutions to using water more wisely.



Last spring, through hands-on workshops, we learned how to convert our washing machines for graywater use, convert a lawn into a native landscape and built backyard rainwater catchment systems. This spring, our Watershed Program will be advocating for bioswales within parking lots and in new developments in order to prevent water pollution and decrease peak flows in local streams as well as to recharge the groundwater. Individually, all these solutions are small, but together they help us reshape the urban environment and conserve scarce natural resources to live within our means.


8 Evenings with the Respectful Revolution: Putting Ideals Into Action
