

On Saturday November 15th, the community is invited to join BEC in planting Blue Oak Acorns in Upper Bidwell Park. Join us and give back to the park by helping to restore the oak woodlands we love.

During the morning we'll be digging, caging, and watering. Wear closed-toe shoes, long pants, and layers, and bring a reusable water bottle.

City of Stumps?

You may have caught recent media coverage of BEC's appeal to the Chico City Council to reconsider a **tree removal permit for 25 Sycamore trees** on Mission Ranch


Blvd. Here's the <u>CN&R article</u> and the <u>Chico ER article</u> on this story, and you might have seen last night's news coverage on Action News Now.

BEC is speaking out, not just for these 25 trees, but also to urge City Council to consider the bigger picture of Chico's urban forest and the disturbing trend we're experiencing, where tree removals have outpaced tree plantings for the past six years.

Since this issue has received a fair bit of publicity in recent weeks, a lot of

concerned citizens have contacted BEC to say thank you for speaking up for the trees and that they share our concern about how many trees are being removed. A good number of them came to the **City Council meeting on Nov 4** to show their support for better protection of Chico's urban forest.

BEC filed the appeal to ask Council to reconsider this particular tree removal permit and to explore alternatives to cutting down these 25 trees or to consider conditions or amendments, such as replanting more trees than are being removed, in an effort to mitigate for the loss of the mature trees and the value they provide.



Chico hasn't has an urban forester on

staff since Denise Britton left in August 2013. The city council approved funding in this years' budget for selection of a part-time contract urban forester, but the position still hasn't even been posted. Meanwhile, the final draft of the Urban Forest Management Plan, presented in November 2012, has been sitting on a shelf for two years.

Until it's adopted and implemented, **Chico's municipal code lacks any protections for the approximately 35,000 street trees** in the public right-of-way. There are an estimated 4,400 vacant spaces where street trees could/should be planted.

After an hour and half of worthwhile discussion and public testimony at last night's City Council meeting (Nov 4), Council approved the tree removal permit (5-2). The decision was disappointing, but our efforts for broad protection of Chico urban tree canopy will continue.

Blitz Tree Planting on Nov 8

A year ago BEC appealed the removal of a pair of oak trees on the corner of 8th and Salem. We eventually withdrew the appeal in part because the Salvation Army graciously agreed to plant more trees, but we also called for the draft Urban Forest Management Plan to be adopted. At the City Council's last goals setting session, they set the goal of adopting



the Urban Forest Management Plan within a year, and charged the Park Commission with finalizing the draft. Meanwhile the City has cancelled nine of the last twelve tree committee meetings and no progress has been made on the forest plan.

This weekend, CSUC students from Construction Management and the department of Geography are **planting 18 trees** around the Butte County Housing authority project on Humboldt, and we are using the draft forest plan to guide us. Eighteen trees added to the urban forest sounds wonderful, until you hear that 25 more are coming down (see previous article about Sycamores on Mission Ranch Blvd). By the City's own reports, in each of the last five years, the city has cut down more street trees than it has planted (see graph in previous article).

Chico Tree Advocates Thanks You for Your Support!

Local Fracking Bans Meet with Some Success

On October 23, a couple dozen of us spoke at the Butte County Planning Commission meeting to make the case for banning fracking.

We were so grateful to see how many citizens showed up that day, including a good showing from farmers who spoke out about the risk of contaminating our water resources. The pro-fracking voices were also there, some of whom appeared to be well-paid lobbyists for the oil and gas industry, but we certainly outnumbered them.

The outcome of the meeting was that the Commissioners are still considering revisions to the draft ordinance. The next public hearing will be held on Thursday, December 11th in Oroville.

We've been working so hard for so long that it's disappointing that this keeps getting dragged out for more months. But this time-frame is pretty typical and we'll just keep working on it.



Meanwhile, several other counties had success banning fracking at the November ballot: **San Benito County passed a ban with 57% of the vote**, and **Mendocino County voters banned fracking with 67% support**. However, in Santa Barbara County, a fracking ban lost after oil industry groups spent more than \$7.6 million to beat the measure placed on the ballot by local grassroots groups. This is what we're up against!
